3. TO APPROVE THE MINUTES OF THE LAST MEETING

4. ACTIONS FROM THE LAST MEETING

• ACTION - FA to draw up a terms of reference for transparency PMB and bring back to the meeting in due course FA circulated this week – AM thinks is a good idea but questioned where the information and contents come from? What is the functional role of this PMB?

AM confirmed he does not currently have a break down on data for international and home students but he believes it was taken.
